1. LEGAL TERMS AND DEFINITIONS.

- 1.1 **Product**. The product herein is ECOJETBOX IMPULSE GENERATOR. The product can be one of two models: 1-truck model 24V, 2-CAR/SUV model 12V. Technical description and packing information of the models are shown in Annex 1 of this contract which is an integral part of the present contract.
- 1.2 Models herein are:
 - 1.2.1 ECOJETBOX IMPULSE GENERATOR truck model 24V,
 - 1.2.2 ECOJETBOX IMPULSE GENERATOR CAR/SUV model 12V.
- 1.3 **Fuel:** herein are gas, gasoline, and diesel.
- 1.4 **Vehicle:** herein is an automobile that is moved by only an internal combustion engine, which in its turn uses gas, gasoline, or diesel as fuel and that has a 12V or 24V electric system.
- 1.5 **ECOJETBOX COMPANY** is Mr. Nurzhan Toishy herein.
- 1.6 **Proof of delivery.** The document with the signature of the buyer or buyer's representative, contains the date of receiving, a destination address, and the description of the parcel. See the example in Annex 2 of the present contract, which is an integral part of the present contract.

2. SUBJECT OF THE CONTRACT.

- 2.1 The Seller sells and the Buyer buys the products according to Annex 1 of the present contract, which is an integral part of the present contract.
- 2.2 The Seller guarantees that the product is free from the rights of third parties, is not pledged, and is not burdened.
- 2.3 The buyer acquires the product to use it on his vehicle or vehicles described in Annex 3 of the present contract which is an integral part of the present contract.
- 2.4 The total price of the contract with the sales tax is _____.
- 2.5 The buyer agrees to follow the test instructions set forth in Annex 4 of the present contract, the user instructions set forth in Annex 5 of the present contract, and the safety instructions set forth in Annex 6 of the present contract which are all integral parts of the present contract.
- 2.6 The buyer agrees to the warranty and disclaimer clauses set forth in Annex 7 of the present contract which is an integral part of the present contract that come with the product hereunder.

3. DELIVERY AND PAYMENT.

- 3.1 The Seller ships the product to the shipping address of the Buyer set forth in article 10 of the present contract in models and quantity according to Annex 1 of the present contract within two business days after the date of signing the present contract by the parties.
- 3.2 The Buyer pays for the delivered products according to Annex 1 of the present contract within two business days after the date of receiving the products.
- 3.3 The date of receiving the products is the date of the proof of delivery.
- 3.4 The seller provides the documents for the product:

- 3.4.1 an invoice, and a packing list upon shipment.
- 3.4.2 a receipt upon receiving the payment hereunder.
- 3.5 The buyer carries out the acceptance of the goods. Sends the proof of delivery copy to the Seller.
- 3.6 The buyer timely pays the total of the delivered goods according to Annex 1 herein.

4. OBLIGATIONS OF THE PARTIES AND LIABILITIES.

- 4.1. For non-fulfillment or improper fulfillment of obligations under this Contract, the Parties are liable under the current legislation of the United States of America, California, and this Contract.
- 4.2 The obligation to pay fines and penalties arises only after sending the relevant written request to the guilty Party.
- 4.3 In case of violation of the terms of delivery of the Equipment, the Buyer has the right to demand from the Seller payment of a penalty in the amount of 0.1% of the contract price for each calendar day of delay in shipping the product to the seller but not more than 5% of the total contract amount set forth in Annex 1 hereof. Any delays caused by the third-party transportation company hired by the buyer to deliver the products to the Seller are not subject of penalties put on the Buyer herein.
- 4.4 In case the Buyer violates the terms of payment for the Equipment, the Seller has the right to demand from the Buyer to pay a penalty in the amount of 0.1% of the unpaid amount for each calendar day of payment delay but not more than 5% of the total contract amount set forth in Annex 1 hereof.

5. FORCE MAJOR

- 5.1 None of the Parties shall be liable to the other Party for failure to comply or improper performance of the obligations under the present contract if such non-performance or improper performance is caused by force majeure circumstances (force majeure), arising against the will and desire of the Parties, which cannot be foreseen or avoided, including declared or actual war, civil unrest, epidemics, blockades, earthquakes, floods, fires, changes in the legislation of the country, and other emergency and unavoidable under the given circumstances.
- 5.2 In the event of force majeure circumstances, the Parties shall, within 3 (three) business days notify the other Party in writing by any available means providing timely receipt of information and provide a document issued by the relevant competent authority confirming the existence and duration of force majeure. The notice must contain data on the nature of the circumstances, an assessment of their impact on the possibility of fulfillment by the Party of his obligations under this contract, as well as the expected timing of their actions. Failure to notify or untimely notification deprives the Parties of the right to refer to the above circumstances as a basis for exemption from liability for non-fulfillment of obligations.
- 5.3 The term for the fulfillment of obligations under this contract is postponed in proportion to the time, within which such circumstances apply.

6. TERMINATION OF THE CONTRACT

- 6.1. The Contract comes into force from the moment of its signing by both Parties and is valid until full fulfillment of obligations under it.
- 6.2. The Contract may be terminated early by the mutual agreement of the Parties, drawn up in writing.

- 7.1. All disputes or disagreements arising between the Parties in the course of execution of this contract are resolved through negotiations.
- 7.2. Disputes and disagreements not settled by the Parties in the negotiation process are subject to resolution in the Court of Los Angeles.
- 7.3. The party that received the claim must consider it within 5 (five) business days from the date of its receipt and either satisfy the claim or give a reasoned refusal. No response to the claim within the specified period means the refusal to satisfy the claim.

8. INFORMATION AND PRIVACY

- 8.1. The Parties keep Confidential Information and take all necessary measures for its protection, including in the event of reorganization or liquidation of the Parties. Parties hereby agree that they will not disclose or allow the Disclosure of Confidential Information to any third parties without the prior written consent of the other party, except in case of unintentional and/or involuntary disclosure of Confidential Information due to force majeure circumstances or due to the requirements of the current legislation of the USA, effective decisions of a court of relevant jurisdiction or legal requirements competent public authorities and administration, provided that in the event of any such disclosures: (a) A Party shall notify the other Party in advance of the occurrence of the relevant event, with related to the need to disclose Confidential information, as well as the conditions and the timing of such disclosure; and (b) The Party will disclose only that part of the Confidential Information, the disclosure of which necessary due to the application of the provisions of the current legislation of the USA, decisions of courts of relevant jurisdiction that have entered into force or legal requirements competent authorities of state power and administration. The relevant Party to this contract is responsible for the actions (inaction) of its employees and other persons who have gained access to Confidential Information.
- 8.2 Disclosure of Confidential Information means actions of one Party not authorized by the other Party, as a result of which any third parties get access and the opportunity to familiarize themselves with the Confidential information. Disclosure of Confidential Information is also recognized as inaction of the Party concerned, expressed in the failure to provide an adequate level of protection of Confidential information and resulting in access to such information by any third parties.
- 8.3 Any Party shall be liable for damages that may be caused to the other Party as a result of disclosure of Confidential Information or unauthorized use of Confidential Information in violation of the terms of this article, except cases of disclosure of Confidential Information provided for in this contract.
- 8.4 The transfer of Confidential Information is formalized by the Transfer and Acceptance Certificate, which is signed by authorized persons of the Parties.
- 8.5 Transfer of Confidential Information via open channels of telephone and facsimile communication, as well as using the Internet without taking appropriate protection measures that satisfy both parties, is prohibited hereunder.

- 9.2 All changes and additions to the Contract are valid only if they are made in writing and signed by authorized persons of both Parties.

REQUIREMENTS AND STEPS (INSTRUCTIONS) FOR THE TEST EFFORTS:

Requirement on the Condition of the vehicle.

All the parts of his vehicle must be in normal working condition as designed by the manufacturer. In case some parts of the vehicle are not in normal working condition as designed by the manufacturer then the user should not connect ECOJETBOX impulse generator to his vehicle.

Requirements on speed, distance, weight, fuel, fuel price, and road for testing:

- 1. Take ECOJETBOX impulse generator out of the box.
- 2. Take the Interior connection wire (cigarette lighter socket) out of its plastic bag.
- 3. Connect the interior connection wire to ECOJETBOX impulse generator.
- 4. Go to the vehicle. Open the door of the vehicle.
- 5. Make sure that your purchased model of ECOJETBOX impulse generator is matching the type of your vehicle: Truck model 24 V is used on the trucks with 24V electric system while car/SUV Model 12V is used on cars and SUVS with 12V battery.
- 6. Make sure that your vehicle is not started or its battery is on before you connect ECOJETBOX impulse generator. The vehicle's electric system must be completely off.
- 7. Find a vacant cigarette lighter socket inside the interior of your vehicle.
- 8. Insert the connector of the Interior connection wire into the cigarette lighter socket. Make sure you connected it firmly and tight without gaps in connection.

- 2. Do not put in water or any other type of liquid.
- 3. Do not drop or throw ECOJETBOX.
- 4. Do not keep at low, high temperature or under the sun or near radioactive substances and chemically active substances.
- 5. Keep away from children.
- 6. Do not connect to anything except vehicles working on gas, gasoline, and diesel fuel that have only 12V (for car/SUV MODEL 12V) and only 24V(for truck model 24V) in their electric system.
- 7. Any vehicle working on gas, gasoline, or diesel has protection fuses of 5A minimum. ECOJETBOX impulse generator uses the connection wires where there is an installed fuse of 2-3A. That means that the protection system of our product will react to any short circuit in your vehicle's electric system that equals or exceeds 2 or 3A. Our fuse will protect your car earlier in this case while the fuses of your vehicle will react only if the short circuit equals or exceeds 5A.

WARRANTY COVERAGE

- 1. This Warranty covers that ECOJETBOX COMPANY replaces the purchased ECOJETBOX impulse generator that has factory defects with another new ECOJETBOX impulse generator within the warranty period (for COJETBOX impulse generator the warranty period is 1 year after the purchase date, and for connection wires, the warranty period is 7 days after receiving date). The warranty is given against ECOJETBOX impulse generator, interior connection wire, and fuse box connection wire that have damages or defects caused by the manufacturer. The replacement ECOJETBOX impulse generator, interior connection wire, and fuse box connection wire will be sent to the user by USPS mail service at ECOJETBOX COMPANY's expense in the boundaries of the territory of the USA using USPS company. This clause covers three items in a package: ECOJETBOX impulse generator, interior connection wire, and fuse box connection wire.
- 2. In case the user discovers the purchased ECOJETBOX impulse generator is not working during the course of the Warranty period, the user is to send it to ECOJETBOX COMPANY at his own expense using USPS company. If ECOJETBOX impulse generator is not working due to the fault of the manufacturer then the cost of return will be indemnified by ECOJETBOX COMPANY against the proof of payment to USPS related to the return.
- 3. If within 7 calendar days from the date of receiving the purchased interior connection wire, and fuse box connection wire that is included as an accessory to ECOJETBOX impulse generator are not working, the user is to send it to ECOJETBOX COMPANY at his own expense using USPS company. If the connection wires are not working due to the fault of ECOJETBOX COMPANY then the cost of return will be compensated by ECOJETBOX COMPANY against the proof of payment to USPS related to the return
- 4. The warranty is valid only if it was not damaged by improper use of the ECOJETBOX impulse generator by the user.
- 5. The warranty period may be extended by ECOJETBOX COMPANY in cases described on the website: www.ecojetbox.com See, the EXTENDED WARRANTY chapter there.
- 6. ECOJETBOX COMPANY warrants the ECOJETBOX -branded hardware product and accessories contained in the original packaging ("ECOJETBOX IMPULSE GENERATOR") against defects in

 - 2. Damage is caused by a road accident, fire, flood, other natural disasters, or other conditions falling under the concept of force majeure.
 - 3. ECOJETBOX impulse generator was installed and connected to the fuse box of the user's vehicle not by ECOJETBOX COMPANY staff or by specialists unauthorized by ECOJETBOX COMPANY.
